# ITEM NO.04. WAIVING OFF THE DEMAND OF RENT OF "POP CORN POINT" AT THILL MARKET BEING CLOSED DUE TO ADMINISTRATIVE REASONS.

To consider the report of Asstt Revenue Supdt, CB Mangla, dated 29.05.2018 regarding non recovery of rent of a "Pop Corn Point" at Thill Market, Mangla Cantt. As per record available in the relevant file permission was granted to Mr. Siddique Masih S/O Sodaghar Masih temporarily for installation of a "Pop Corn Point" at Thill Market, Mangla Cantt vide letter No.CB/C-7/Misc/74, dated 26.05.2018 at monthly rent of Rs.500/- w.e.f. 01.06.2016. Reportedly the said point was closed by the tenant. The above named person has not run his business at site in the year 2017-18 but annual demand of Rs.8,580/- exists in the register upto 30.06.2018 alongwith arrears of Rs.2200/-. Total amount comes to Rs.10,780/- which is irrecoverable due to non-availability of whereabouts of the temporary occupant of the point.

Approval for deletion of demand with effect from 01.07.2018 and waiving off the irrecoverable amount of Rs.10,780/- is solicited as required under section 102 of the Cantonments Act, 1924.

# ITEM NO.05. GRANT OF EXEMPTION IN THE PAYMENT OF RENT OF KIOSK BEING CLOSED ON THE DIRECTIONS OF ARMY AUTHORITIES ON ADMINISTRATIVE REASONS.

To consider the application, dated 14.06.2018 submitted by Mr. Faryad Masih S/O Yousaf Masih, Resident of House No.12/1, Thill Colony, Mangla Cantt. for grant of exemption in payment of rent of the Kiosk which was installed at Thill Market and shifted from original point to Wagon stand due to administrative reasons upon directions of higher army authorities. The kiosk remain closed w.e.f. 01.11.2017 to 31.05.2018. Now as per his statement, the Sta HQ Mangla has allowed to continue his business at new site w.e.f. 01.06.2018. He has also deposited the rent for June, 2018 @ Rs.1486/- vide Bank Challan No.034/71, dated 29.06.2018.

The request of applicant for grant of exemption for payment of rent of kiosk for 07 months from Nov, 2017 to May, 2018 and running of his business at new place with effect from June, 2018 on payment of monthly rent of the Kiosk @ Rs.1486/- per month is placed on the table for consideration.

### TEM NO.06. AMENDMENT IN CBR NO.21, DATED 10.05.2018.

To consider and approve the amendment in the CBR No.21, dated 10.05.2018. In the said CBR, due to a typographic mistake area of class "C" land at survey No.84, Baral Market was shown as 1144 Sq Mtr instead of 1334.777 Sq. Mtr. which needs amendment.

### ITEM NO.07. NON RECOVERY OF RENT OF 13 NO. CB SHOPS AND ONE KIOSK AT SURVEY NO.84, BARAL MARKET, MANGLA CANTT.

To consider the report of Asstt Revenue Supdt CB Mangla regarding further course of action in the matter of non recovery of rent of 13 No. CB Shops and 01 Kiosk, situated in Baral Market, Mangla Cantt. The army authorities has started work of extension of Station Officer Mess infront of above mentioned shops, resultantly passage of customers towards shops is permanently blocked and the tenants have stopped the payment of rent with effect from March, 2018. The case regarding consideration about the "Financial loss to CBM due to extension of Station Officer's Mess, Baral Colony, Mangla Cantt" was placed before the Board and the Board vide CBR No.21, dated 10.05.2018 resolved to "request the Sta HQ Mangla to take over the possession of 13 No. Cantt Board shops and make payment of superstructure alongwith swap over of equal piece of land of Class "C" land with Class "A-1" land in the same vicinity".

Decision with regard to stoppage of demand of rent w.e.f. 01.03.2018 till the solution of the matter is solicited.

Case file is placed on the table.

#### RESOLUTION.

Considered, discussed at length and resolved to ask the tenants to vacate the shops as the same are required for extension of the Station Officer's Mess. Since the shops are being demolished by HQ 1 Corps, Corps HQ be asked to provide alternate land in lieu of this land. It is further resolved to stop the rent demand of the subject shops and kiosk in Demand and Collection Register w.e.f. 01.03.2018.

Moreover, highest bids of Shop No.1, Block No.1, adjacent CB Workshop & Shop No.1 Block 2 Adjacent to CB Staff Quarter be cancelled due to non payment of balance amount of premium by the bidders and Shops No.1 & 2, Block-1 adjacent to CB Workshop and Shop No.1, Block -2 adjacent to CB Staff Quarter be allotted to Mr. Muhammad Nawaz, Mr. Javed Masih and Mr. Muhammad Yaqoob, as verbally agreed by them on monthly rent of Rs.5400/-, Rs.4000/- and Rs.5400/- respectively as alternate against vacation of Shops No.36, 37 & 34-A, Baral Market,

Mangla Cantt.

# ITEM NO.08. TRANSFER OF LEASE HOLD RIGHTS OF PROPERTY NO.41-B, SITUATED IN CB HOUSING SCHEME, MANGLA CANTT.

To consider the application, dated 09.04.2018 submitted by Mr. Musawar Hussain S/O Muhammad Akbar (CNIC No.37402-3415106-5) requesting therein for transfer of lease hold rights of property No.41-B, Street No.6, situated in CB Housing Scheme, Mangla Cantt. in his name on the basis of Sale Deed, executed the existing lessee Mr. Muhammad Ali S/O Karam Dad, registered with Sub-Registrar Dina, Distt Jhelum on 30.01.2018.

The land is class "B-3" (open plot) measuring 334.46 Sq Mtr held on lease in Schedule X (Modified) of CLA Rules, 1937 (residential purpose) for 90 years upto 24.03.2088.

Notices in this regard were published in Daily "Express" and Daily "Dawn" Lahore on 16.05.2018 and 17.05.2018, respectively inviting objections from general public but no objection was received within stipulated period. The applicant has already deposited an amount of Rs.1,68,500/- (Rupees One Lac Sixty Eight Thousand Five Hundred only) vide Bank Challan No.046/66, dated 08.06.2018 on account of TIP Tax and Mutation Fee etc.

Transfer of Lease Hold Rights in favour of applicant is solicited.

Case file is placed on the table.

#### ITEM NO.09.

### PAYMENT OF THE COST OF ITEMS LYING IN SHOPS NO.17, 34 & 35, BARAL MARKET AT THE TIME OF TAKING OVER POSSESSION BY CBM.

To consider about the further course of action on the application, dated 06.06.2018 submitted by Lt. Col (Retd) Shamim Ahmed requesting therein that he had spent Rs.1,88,655/on the directions of Sta HQ / Cantt Board Mangla on the renovation of Shops No.17 Baral Market out of his own pocket subject to adjustment in the monthly rent of the shops. He stated that an amount of Rs.1,20,000/- has been adjusted against monthly rent of the shop and balance amount of Rs.68,655/- is payable by CB Mangla as the shops were taken over by the CBM on 09.09.2015. He also claimed an amount of Rs.2,15,150/- on account of cost of items lying in the shop No.17, at the time of sealing of shop and taking over the possession by CBM.

He further claimed that Shops No.34 & 35, Baral Markets were also under his occupation but the items lying these shops were not handed over to him at the time of vacation, and requested that cost of these items amounting to Rs.1,44,700/- be paid to him.

As per record of this office, case history is given as under :-

- Shop No.17 was allotted to the applicant by way of transfer vide CBM letter No.CB/Shops/17 Baral/1736, dated 03.04.2012, with effect from 01.03.2012 at monthly rent of Rs.4273/-.
- Reportedly shops No. 34 & 35 were also under his occupation but CBM record is silent about their allotment to the applicant.
- Upon investigation in the matter, it has been found that the hotel articles were not handed over to the applicant at the time of vacation of the shop and these are still under the use of present tenant of Shop No.17, Baral Market,

As per report of ARS the then PCB vide Minute No.067, dated 12.03.2014, allowed the amount of Rs.1,00,000/- for renovation of the shop building by the applicant subject to adjustment in the monthly rent which was adjusted according. However decision about the retrieval of hotle items or payment of the cost of items to the applicant is solicited.

Relevant documents are placed on the table.

#### RESOLUTION.

Considered and discussed at length. Keeping in view the decision of the then PCB passed vide Minute No.067, dated 12.03.2014 claim of applicant regarding payment of balance amount of Rs.68,655/- by CBM on account of renovation charges of shop is not justified. However, the present tenant of Shop No.17 be directed to either hand over the items to the applicant as per list available on record or compensate as payment of the cost of items viz Rs.2,15,150/-, otherwise his tenancy agreement will be cancelled and the shops will be got vacated at his own risk and cost.

#### ITEM NO.10. BYE-LAWS FOR REGULATING AND CONTROL ON LEVY OF PARKING FEE.

To consider and approve the Draft Bye-Laws for" regulating and control on levy of Parking Fee" in Mangla Cantt. The Draft Bye-Laws were earlier approved by the Board after inviting objections from the general public through publication of advertisement in the News paper vide Minute No.064, dated 31.01.2014 and the case was submitted to the HQ ML&C Deptt Rawalpindi vide letter No.CB/Admin/Parking/3281, dated 26.03.2018 but after raising certain queries by the Deptt and protracted correspondence in this regard, upon directions of MoD, conveyed by the HQ ML&C Deptt vide letter No.17/2/P&MA/ML&C/POV/2017, dated 13.04.2018 received through RHQ Lahore vide letter No.20/53/RD/LR/21, dated 11.05.2018 to route the proposal under the relevant provision of the Cantt Act, 1924 and amend the draft notification as per requirement of the section 61 of the Act ibid. The objections were again called through publication of advertisement in daily "The News" and daily "Express", Lahore dated 16.05.2018 fulfilling the required formalities, but no person turned up with, or filed objection, suggestion or observation within stipulated period as specified in the Notices. After approval by the Board the case will be forwarded to MoD through HQ ML&C Deptt for publication in the official Gazettee.

Draft Bye-Laws are placed on the table.

The contract of collection rights of Toll Tax was awarded to the applicant @ Rs.48.00 million per annum but quantum of vehicle passing through toll tax post remain less due to closure of Dina Mirpur road near MP Check Post No.1, Mangla Cantt. for construction of bridge by the Highway Department. As per clause 10 of the draft agreement of collection rights of Toll Tax, to verify the situation, a committee was formulated consisting of ARS, Tax Collector & Office Supdt.
